FIRST, WE SUPPORT THE NEEDY STUDENTS IN PURSUING AS MUCH EDUCATION AS THEIR ABILITY AND DESIRE DETERMINE. IN 2018, WE SUPPORTED 75 PRIMARY STUDENTS, 16 SECONDARY STUDENTS, AND 24 POST-SECONDARY STUDENTS, PAYING FOR SCHOOL FEES AND SCHOOL SUPPLIES, GIVING THEM FOOD DAILY (2 MEALS/DAY), HEALTH SCREENINGS, EXAM TUTORING, COUNSELING, VACATION PROGRAMS, ETC.
